I had taken a hiatus from writing my "Musings" for several months, not due to any lack of subject material, but of necessity due to preparation for several upcoming classes. Alas however, the controlled media will not allow me to rest. The latest object of my "hate and discontent" is the absolutely heart-felt confession supposedly attributed to Timothy McVeigh vis-à-vis the infamous Oklahoma City Bombing. This information has supposedly come from some sort of "computer hacking" activity of McVeigh's attorney's records in his Denver office. Come on folks, as the saying goes, I may have been born at night, but not last night! The gentle whiff of rodent again wafts in the Spring air...

As you well know I have always suspected that the Bombing of the Murrah Building bore the fingerprints of gentlemen well up the ladder from anyone so insignificant as "Timothy McVeigh". This is probably not the place to discuss the bombing in great depth, so I will attempt to limit the comments to those issues concerning the activity(s) of McVeigh and his complicity in the chain of events leading up to the disaster.

If you were to ask me, "are you saying that you don't believe that McVeigh made such a confession?" My answer would have to be "that's not what I'm saying at all." He may well have made such a confession, and he may well believe that he alone was responsible for the actions that took place on that April morning two years ago! In fact, I would make book that McVeigh could pass a "lie detector test" attesting as to his sole guilt in the Oklahoma City Bombing! What I am saying is that if you take this "supposed confession" to be gospel and make the assumption that this constitutes a "case closed" end to a long investigation, think again my friends, think again...

The believability factor for the supposed confession is somewhat jaded for the following reasons:

1) The Federal Government has had young Timothy incarcerated and away from "prying eyes" for almost two full years.

2) The facts in the Oklahoma City Bombing case are anything but straightforward. Too many conflicting stories are floating around from eyewitnesses. The 20/20 Story (on the bombing witnesses) of a month or two ago raised many questions that would not support the "McVeigh did it all by himself" theory (no matter how badly the government wishes it!).

3) Individuals in our Government have been known to get "heavy handed" with the facts in certain cases in years past. Character assassination has often been used by both our federal law enforcement and other highly placed officials to negate the effectiveness of individuals considered to be... shall we say "a liability" to the official position. Case in point; the "infamous" General Edwin A. Walker. In the early 1960's General Walker (a highly decorated combat veteran of two wars) was convinced that there was a threat to our country from subversive elements (mostly Communists in those days). While this was in fact true, his motivational speeches to his troops in Europe caused considerable "heartburn" to the "power that be (1)" in the Federal Government. General Walker was told to "cease and desist" or face being relieved of his command and be considered for possible disciplinary action. He got the "message", chose to retire and return to the United States to carry on his crusade against those he considered a threat to our National Security. Whether he was right or wrong (events later proved him to be basically "understating the problem"), he was simply exercising his rights under the 1st Amendment to the Constitution. The Government saw it otherwise, he was (in their opinion) not following the "party line", and as a high profile (former) "Governmental Icon" he had to be crushed like a grape as a lesson to any who might follow his example. He was arrested in Oxford Mississippi for "inciting students to riot" on the Campus of the University of Mississippi. It was later proven that he was attempting to convince the students to cease and desist... The Government, believing an AP press release, and without further proof; arrested General Walker and held him without benefit of bail or access to an attorney... he was then spirited out of Mississippi on a Border Patrol aircraft and incarcerated in the Federal (Medical) Prison in Springfield, Missouri. A Government "shrink" (from his Washington D.C. office, no less) proffered the opinion that General Walker was mentally ill without ever seeing the man. Even though the Justice

Department had planned on keeping him incognito for at least 90 days while "examining him", he became such a political "hot potato" for Robert Kennedy, Walker was released after eight days. A subsequent mental exam by an independent psychiatrist stated that Walker was mentally sound and operating on a superior level of intelligence. My point is that this was a deliberate attempt to falsify the facts and assassinate General Walker's character to suit the Government's political agenda. Dangerous stuff indeed!

4) Coincidentally with, and actually predating (2) General Walker's dilemma was the establishment of the CIA's MK/ULTRA experiments at Edgewood Arsenal. These experiments had their origins in the aftermath of the Chinese "brainwashing" activities on our POWs during the Korean War. We (quite correctly) felt that we needed to have a thorough grasp of brainwashing techniques to properly indoctrinate our military forces prior to another conflict with the Communists. The experiments no doubt started out innocently enough, but before they were through, it became a case of "if you think THAT was effective, watch THIS!" Volunteers were called for from both the civilian and the military establishment. These experiments included the administration of many drugs that still plague this country to this day; LSD, PCP (both CIA concoctions), marijuana, heroin, cocaine, mescaline, and amphetamines. The drugs were simply "add-ons" to such activities as lobotomies, sleep deprivation, electroshock, AND "subliminal suggestion"! It is rumored that Dr. Louis "J". West (3) examined McVeigh at Tinker AFB prior to Timothy's being incarcerated in a Federal Prison. Dr. West's activities on mind control are said to have been extensive during the early 1960s. Dr. West currently denies that he ever examined McVeigh of course, but what would you expect? If I were involved in a governmental attempt to "warp" McVeigh's mind, I would take great pains to dissociate my involvement with the entire agenda... Ultimately the Edgewood Lads and MK/ULTRA made the Chinese look like kindergarten-types... Even Dr. Timothy Leary and John Lennon credited their "success" to the CIA Scientists and their LSD experiments. My point should be crystal clear! "Lee Harvey McVeigh's" confession does not (or at least should not) constitute an ironclad case for the U. S. Government!

5) Since Timothy McVeigh has been incarcerated far from prying eyes for almost two years by a government that has become "expert" in mind-warping techniques; quite frankly I wouldn't believe him if he told me his real name was Timothy McVeigh! By now he could well be programmed to say AND believe that black is white! Confessions are strange things indeed. One afternoon in the DMZ while serving as the Intelligence Officer for an Infantry Battalion I fell heir to several NVA prisoners. Within the space of approximately two hours two of these lads had confessed to the assassination of Abraham Lincoln and one had me convinced that he had personally started the Chicago Fire... and I only had them for two hours, not two years! If you ask the right questions and offer the proper alternatives and incentives, virtually anyone can be made to say anything ...and believe it!

6) The blast of the "fuel oil/ammonium nitrate" explosive could not have accomplished the damage done to the Murrah building. I speak here as an Ordinance Engineer. Back in the early 70's I had the opportunity to work on the FAE (4) experiments. I have worked with explosives extensively and I'm here to tell you that the amount of "explosive fertilizer" capable of being packed into a Ryder Truck of the size specified could NOT have produced an explosion capable of doing the damage inflicted on the Federal Building in Oklahoma City. That explosion not only called for a sophisticated device well beyond the capabilities of Timothy McVeigh's expertise, but eyewitnesses have stated that the internal columns were taken down by explosives planted within the building itself. The building was almost immediately demolished by the government as a hazard to the public... (perhaps to prevent close examination of the internal columns?). A seismic plot that recorded the explosion(s) on

that fateful morning, actually recorded TWO explosions approximately 10 seconds apart. Fuel Air Explosives require a two stage explosion (albeit virtually simultaneous), but requiring a device well beyond the ability of any of the Militia Groups to acquire or fabricate (governmentally furnished?... or planted?). One of the two explosions had to be the internal explosion (FAE?) and the other would have to have been the truck (the government's "plant"/excuse/de-facto cause?). Unless someone talks, we'll never know for certain of course... and if McVeigh confesses? Hummm... It should be noted that the "confession" now alludes to McVeigh's "remembering" that he pulled two separate "fuse lighters" to set two separate charges within the truck. This is probably a variation of what we used to call "dual non-electric priming", designed to ensure that the explosive always detonated, even if one primer/blasting cap misfired. If I were of a devious frame of mind, I might even think that McVeigh now remembers setting two charges to account for the two blasts recorded by the seismic device... convenient?... or coincidence? What do you think?

"OK, what **DO** you think happened" might well be a legitimate question at this point! I'll have to give you a "weasel-worded" answer. While (without getting into some information that I am not at liberty to divulge) I can't absolutely say what happened, I can tell you with a fair degree of certainty what DIDN'T happen. Let's make a list, and you can make up your own mind:

1) McVeigh was probably recruited by "the principals" who set up the incident. He was chosen for his youthful enthusiasm and lack of experience (except as an Army "grunt"), ... and probably because he wouldn't ask too many "far reaching" questions. Appropriate anti-government rhetoric and McVeigh's desire to be important no doubt brought him aboard... Here we're guessing of course, but I strongly suspect that this or something very like it constituted the modus operandi of the gents (or "A"gents) in charge...

2) McVeigh was designed to be the "straw man" or "patsy"(5) if you will, to take the fall when and if everything went to absolute "doo-doo". It **HAD** to go to "doo-doo" of course. The object of the exercise (at least in part) was to create a reason to go after the Militia Groups. ...And as an excuse to pass the more onerous portions of the Omnibus Anti-Terrorism Bill that was rapidly losing its luster with the (then) new Republican Congress in April of 1995.

3) Why would any competent attorney leave such damning evidence (as McVeigh's so-called confession) in his files? How could anyone "hack the computer files" if the computer were not:

a) ...left turned on?

b) ...left hooked up to the Internet?

Something smells about this one... It's just too good to be true, and considering the trial date... very coincidental and convenient wouldn't you say? It makes you wonder what the attorney's price was? Am I suspicious? You bet your "bippy" I am! Coincidence and convenience again rear their ugly heads!

4) One must also ask why the Feds (in black suits and heavily armed) stopped the rescue efforts three hours after the blast while "un-rescued" victims were still dying in the rubble. The area was cordoned off while several military style "field ambulances" were loaded with cardboard boxes (6) (presumably full of files... who wants to "rescue" an empty cardboard box?). Rumor control has it that all the Government records of the Mena

(Arkansas) drug running operation (7) were stored in the basement of the Murrah Building. Also rumored to be stored in the Murrah building basement were a number of the important files on the Whitewater case. Now why in the world would anyone put all those files from the Arkansas "Capers" in the Federal Building in Oklahoma City? I must admit, that your guess is as good as mine - unless of course someone KNEW it was going to go up in a puff of smoke? Again coincidence and convenience make strange bedfellows wouldn't you say?

5) You must also wonder why absolutely no members of the BATF were in the Federal Building at 9 AM on a weekday morning. The answer given by the BATF just doesn't wash! They claim that they were taking the morning off because of running a training exercise the night before (That could be, now couldn't it? hummm...). No guys and gals... that just ain't the way it's done in the real world. I was once stationed at a District Headquarters in the Federal Building in New Orleans. Trust me when I tell you, NO agency would leave the office totally unmanned on a weekday morning... what would happen if the Director called? What if there were a Congressional inquiry (always a possibility with the BATF!)? No, you ALWAYS have at least a phone watch, **ALWAYS!**

Their excuse for not manning the office just doesn't cut it... but even if that **was** the case, you still have to ask yourself "why?"... "coincidence and convenience? ...and again ... and again ...and again?"

6) If you'll consult the recent past airing of the 20/20 sequence on the Oklahoma City Bombing (8), you'll have to ask yourself why eyewitness reports of armed individuals in black "SWAT type" suits were ignored in the wake of the investigation. What were these people doing searching (or appearing to search) for something around the outside of the building prior to the blast? Who were they and what were they doing there? ...and why were these witnesses told by the Law Enforcement folks to essentially "sit down and shut up!" during the so-called investigation after the blast?

7) What possible reason could the "powers that be" have to attempt to "quash" the attempt to assemble a Grand Jury to investigate these and other eyewitness accounts that don't jibe with the "official report"? ...And yet this is exactly what has been happening... Ask yourself, "who benefits, and why?" There are some feeble reasons given; usually the answer is that it would duplicate effort and/or would cost the taxpayers too much (since when has THAT ever deterred any government agency?). No, someone out there is VERY nervous. A quick confession by McVeigh conveniently covering all bases would solve a lot of problems for those with a lot to lose...

I don't know how you would add up the rather strange set of circumstances as they apply to McVeigh, but here's my slant. Considering the above points, I think McVeigh is probably guilty of driving the Ryder Truck. I am convinced that McVeigh is convinced that he is guilty of that and much more (probably the entire operation). I would also bet big **BIG** bucks, that he could and would pass any lie detector test conducted concerning such a confession (brainwashing is a strange and wondrous thing). I rather imagine that McVeigh's confession, could, would and/or will be "sold" to the American Public by the Government and the liberal media to accomplish the following:

- 1) A condemnation of the entire Militia Movement as a very dangerous entity.
- 2) This "militia and terrorism scare" will allow the passing of many sweeping and restrictive explosives and anti-firearms laws.

3) A nervous public will allow the passage of many provisions of the onerous "Counter-Terrorism Bill". Search without warrant, essential negation of "habeas corpus" and wire tapping on the flimsiest of excuses will become the norm. All this will be instituted to save us from ourselves of course! ...Bad, bad "ju-ju" my friends... Rights, once lost are difficult to regain! Beware!

4) The "saved files" (salvaged from the basement of the Murrah Building) will never resurface... convenience and coincidence, my friends... Ain't it wonderful?

5) I would not be a bit surprised if McVeigh is suddenly "silenced" by a person or persons (perhaps unknown)... maybe, just maybe by another "brainwashed" subject... or by self destruction (remorse? perhaps - but induced by whom or what?). The ideal solution from a conspiracy standpoint would be to induce McVeigh to stand trial, be convicted and executed before more damning evidence emerges! At this point, it would be "case closed! – Confessed domestic terrorist executed for murder and crimes against humanity." The perfect end to a successful operation, now if we can just shut up those damned conspiracy theorists! Hummm...

End Notes for ("The Saga of Lee Harvey McVeigh")

(1) Specifically the Kennedy Administration had decided that for a "kinder more gentle world" we were gonna' have to learn to "get along with" the Communists... something that did not sit at all well with Gen. Walker.

(2) The MK/ULTRA program was started in 1953 and ran through 1963, with "offshoots" continuing until 1975. Some say that portions of the program are still in existence.

(3) Dr. Louis "J." West (also known as "Jolly West") is currently a Professor of Psychiatry at UCLA and was the examining psychiatrist of Jack Ruby following Ruby's killing of Lee Harvey Oswald. Dr. West is a proponent of implantation of biochips to control violent behavior... hummm... Now where did McVeigh say he had his "chip" implanted?

(4) "FAE" (pronounced "fay") stands for "fuel-air-explosive"... a well-known phenomena (grain elevator explosions are a type of FAE blast). When properly set up with explosive vapors vice flour particles, they produce blast effects all out of proportion to the size of the device.

(5) Hence my tongue-in-cheek reference to Timothy McVeigh as "Lee Harvey" McVeigh after another "pasty" set up in the past by the "High Cabal" (or whatever other "pet name" you may have for them).

(6) These boxes were supposedly carried out on military stretchers along with several long cylindrical objects that appeared to be "rocket-type" launchers...

(7) This is the alleged CIA drug running operation that occurred at the Mena Arkansas Airport while Bill Clinton was the Governor of Arkansas (reputedly with the full knowledge and approval of the "Guv").
